Mission Statement

PART I. GENERAL EXPECTATIONS

The **R.D. Martinez Elementary** agrees to implement the following statutory requirements:

4. The R. D.  - Parent program parents meeting in person and virtual

5. The R.D. Martinez Elementary will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - Providing parent representation on campus by SBDM (site-based decision meeting committee)
 - SPTSO (student, parent, teacher, support organization)

6. The R.D. Martinez Elementary will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

- Sending performance reports to parents (I station, STAAR, TELPAS, AR)
- Report card email and pickup and skyward
- Scheduling parent conference with teacher in person and virtual
- Skyward
- AR home connection

7. The R.D. Martinez Elementary will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph---

- The state's academic content standards,
- The state's student academic achievement standards,
- The state and local academic assessments, including alternate assessments,
- The requirements of Part A,
- How to monitor their child's progress, and
- How to work with educators:
 - Curriculum nights in person and virtual
 - Parent meetings (district) in person and virtual
 - BooHoo-Woohoo breakfast

8. The R.D. Martinez Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement by:

- AR/ Reading night
- Technology meetings (district) in person and virtual

9. The R.D. Martinez Elementary will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions to parents, and in how to implement and coordinate parent programs and build ties between parents and school, by:

- Encouraging staff to attend in person and virtual district PI training- i.e. Blue-ribbon customer service, effective parent conference.

10. The R.D. Martinez will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early
